THE CHALLENGE

Kaiser Foundation Hospitals is proposing to develop approximately 1.2 million square feet of medical campus and commercial use over multiple phases on a 58-acre unimproved, undeveloped project site in Dublin, CA. The Kaiser Permanente Dublin Medical Campus would provide the wide range of healthcare services currently offered by Kaiser Permanente, including outpatient specialty and primary care, radiology, Cancer Center, Urgent Care and Ambulatory Surgery services.

The City of Dublin needs an Environmental Impact Report (EIR) that gives them a clear roadmap for development, while complying with California Environmental Quality Act (CEQA) regulations. Kaiser Permanente proposed an aggressive schedule to complete CEQA review in 2015.
